

## Yates County Farm Bureau Attends State Annual Meeting

Yates County Farm Bureau joined farmer members from across the state at New York Farm Bureau's State Annual Meeting in Albany in December to set the public policy priorities for 2018. The grassroots process was filled with thoughtful discussion and debate on a wide variety of issues ranging from tax policy to music at New York's wineries.

"I believe we put together a sound agenda that addresses the needs and concerns of our diverse membership," said county Farm Bureau President Larry Lewis. "I look forward to working with NYFB President David Fisher, staff and the many dedicated volunteers to enact legislation and ensure investments that will help our farm families grow and thrive."

Delegates from the county Farm Bureau were recognized for their achievements on behalf of the more than 340 families they represent with nine Silver Key Awards. Silver Keys are awarded to counties that attain outstanding achievements by involving leaders and members in programs serving agriculture. The awards were given for excellence in the categories of Membership, Agricultural Education & Promotion, County Financial Management, Information & Public Relations, Leadership Development, Policy Implementation-State & National, Young Farmer and Distinguished President. The county Farm Bureau was presented with a check for \$1,090 for its achievements.

## Major Legislative Victory

*Inherent Risk Reform Becomes Law*

New York Farm Bureau achieved a major victory for farms across the state with passage and signing of inherent risk reform (Chapter 338 of 2017) for agritourism and equine businesses. The new law will amend the general obligations law to clarify responsibilities for both farm operators and visitors alike. Agricultural tourism and outdoor recreation activities that include horseback riding, u-pick Christmas trees and fruit orchards, along with tours of wineries and maple operations, all now have a new line of defense against frivolous lawsuits because of the new law. Until now, New York's litigious environment had diminished the number of carriers willing to cover these businesses, while dramatically increasing the cost of liability coverage. Many farmers have had to turn down opportunities to invite the public onto their farms because they could not find or afford the liability insurance necessary to host these opportunities in the state. Under the new law, farms must have proper signage to delineate pathways and buildings open to the public, adequately train employees involved in agritourism, take reasonable care to prevent foreseeable risks and post warning to visitors about the inherent risks of participating in activities on working farms.

- Double the minimum wage tax credit for farmers starting in 2018.
- Oppose unworkable farm labor mandates and make much needed updates and reforms to NYS labor laws and regulations.
- Increase school meal reimbursements to incentivize the purchase of fresh and minimally processed local food.
- Support the removal of an acreage requirement for farms in the agricultural assessment program as long as they meet income eligibility requirements.
