Asking Gov. Hochul to Veto Ban on Neonics and Treated Seeds

New York Farm Bureau is asking you to e-lobby now to send a letter to Gov. Hochul asking her to veto the so-called "Birds and Bees Protection Act" that would essentially ban the use of several Neonicotinoids, including treated seeds, beginning in 2027. This would have a significant impact for many growers, removing a valuable risk management tool from their farms.

In addition, there are e-lobby letters asking Gov. Hochul to veto legislation that would allow local laws to ban pesticides on wetlands as well as a bill that would categorize class C waterways as streams. You can find the letters at NYFB.org.

EPA Releases New WOTUS Rules

The EPA has rewritten "Waters of the United States" rules in an attempt to accommodate the Supreme Court case that was decided earlier this year, Sacketts v. EPA. Unfortunately, these rules continue to raise concerns for NYFB. While EPA's 2023 rule defining "waters of the United States" was not directly before the Supreme Court, the decision in Sackett made clear that certain aspects of the 2023 rule are invalid.

The amendments issued are limited and change only parts of the 2023 rule that are invalid under the Sackett v. EPA decision. For example, today's final rule removes the significant nexus test from consideration when identifying tributaries and other waters as federally protected.
