# OSWEGO COUNTY FARM BUREAU POLICY DEVELOPMENT RESOLUTIONS 2024

- We support requiring solar companies to notify local fire departments and municipalities of any changes to ownership or contact information so they can easily be contacted in the event of an emergency after construction is completed.
- We support New York State providing training or funding for training to fire departments who will be called to solar array fires.
- Change to policy # 27 Pg. 53 We support New York State mandating and enforcing New York State brewers to use in-state grown ingredients, that are processed and inspected in state, in order to comply with the Farm Brewery Law.
- We support New York State having a real property tax abatement on uninsurable perennial farm crops for one year during a state or federally declared disaster area.
- We support regulation that guarantees freedom of speech and expression on social media platforms. This is necessary to protect the ability to have open debate on controversial topics. Skepticism is an important component of the scientific research process and contrary ideas should not be de-platformed or disadvantaged by social media algorithms.

#### Reaffirmations:

• Pg. 153 # 14 – We strongly support an increased effort by the New York State Department of Motor Vehicles to educate drivers on the meaning and use of the slow moving vehicle sign. Emphasis should be placed on the lawful use of the slow moving vehicle sign and the hazards related to slow moving farm equipment and horse riders and buggies.


