The July/August edition of Grassroots included a section of questions that our Public Policy Department asked you as members to weigh in on. You do so by introducing a resolution at the county Farm Bureau Annual Meeting (notice in this newsletter). Are you frustrated by the rules governing CDL licenses? Our state staff is trying to clarify the law and needs your input to do so. Do you have concerns about how ATVs and UTVs are registered and how they are allowed to be utilized on roadways? One of our members is and will be bringing forth a resolution to be addressed on September 17. Please be thinking about what bugs you and consider using the power of this group you belong to as a springboard to change.

GRAIN BIN SAFETY TRAINING HELD

By the time you receive this, Chautauqua County Farm Bureau will have participated in its third demonstration tackling the safety issue of either Grain Bin Entrapments or Manure Related Asphyxiation. We have helped the county Emergency Management Office to secure a grain bin rescue tube and our county organization has donated a grain auger to supplement this donation so that our county personnel have what they need for a rescue. We used monies raised at our annual Trivia Night for this donation. We have had a good response from our emergency personnel in the county to these trainings and hopefully we are much more prepared for emergency situations
