Dear Farm Bureau members.

Happy New Year! I hope you and your family enjoyed being together over the holidays. As we enter into 2025, it's a good time to reflect on that togetherness – not just in our personal lives, but togetherness in our agricultural communities as well.

Tompkins County Farm Bureau was pleased to attend NYFB's State Annual Convention last month in Verona, NY, where a record crowd enthusiastically shared fellowship, education and new ideas. Most importantly, delegates from across the state came together in a spirited session on State Annual Meeting Day to vote on our 2025 public policy positions.

Some of our top legislative priorities include supporting critical funding for agricultural animal health; increasing funding for the state Farmworker Housing Program revolving loan fund; increasing and extending the farm workforce retention credit; supporting renewable energy policies that incorporate common-sense time frames; addressing transportation issues to facilitate the shipment of food products and farm equipment in New York State; establishing a New York State Equine Advisory Board; opposing the Temperature Extreme Mitigation (TEMP) act unless there is an exemption for agriculture; opposing legislation that prohibits the use of agricultural chemical protectants; and opposing Extended Producer Responsibility legislation that unduly burdens New York's food and wine manufacturing businesses.

As we get updates on state and federal legislation affecting NYS agriculture, we will update you in email communications, on our social media channels and in Grassroots. As always, New York Farm Bureau is committed to promoting and defending agriculture. A recent example of that commitment is the passage of the Direct to Consumer bill, which offers distilleries and cideries the same shipping privileges as wineries. We

#### TOMPKINS COUNTY FARM BUREAU ATTENDS STATE CONVENTION

Tompkins County Farm Bureau helped chart the course for agriculture's future at the New York Farm Bureau 2024 State Convention (StaCon) December 3-5 at Turning Stone Resort Casino in Verona. This year's theme

was "Farming Forward: Leadership, Innovation, Diversification." Workshops and an engaging program were offered to help NYFB members, farmers, and agricultural professionals better plan for the future. Member delegates also voted on public policy positions that the state organization will advocate for the 2025 year in Albany and Washington, D.C.

#### TOMPKINS COUNTY FARM BUREAU RESOLUTIONS REPORT 2024

The following resolutions were all discussed at the County Annual Meeting on October 28, approved and forwarded on for consideration at the District 4 Resolutions Committee Meeting held just before the State Annual Meeting in December. Whether these resolutions died in committee, passed or failed at the State Annual Meeting is indicated after each resolution.

- We support the increase of donations to food banks and food pantries by raising the refundable tax credit from 25% of the crop market value to 50% and raising the credit limit from \$5,000 to \$10,000.
- We support state funding for DEC to eradicate invasive species, particularly hydrilla in the Finger Lakes, as this will completely change the ecology of the lakes if left unchecked. USDA funding is being removed. *Passed*
- We support CDL training at facilities such as SUNY schools that will offer not only training for full large scale truck operators, but smaller pickup truck/ trailer combinations that exceed 26,000 lbs. GVRW. Was morphed into another resolution at the State Resolutions Committee did not pass
- We support a mechanism that will hold tax assessors accountable for gross misinterpretation of Ag tax laws. Passed
- We support increasing emphasis of agriculture at the NYS Fair by capping rental rates for agricultural shows and product sales – and the expansion of 4-H and FFA exhibit space. Added to another resolution.
   Passed
- We support increased funding for county Soil & Water District and Cornell Cooperative Extension Associations. *Passed*
- We support and prioritize an annual appropriation for the NYS Agricultural Experiment Station/Cornell AgriTech for operations and maintenance to ensure the continued viability of the Experiment Station (including the Long Island Horticulture Research and Extension Center, Hudson Valley Research Laboratory, and Cornell Lake Erie Research and Extension Laboratory) to provide research-based solutions and extension for specialty crop farmers. This resolution and the one below were combined into one resolution at the State Resolutions Committee Meeting. *Passed*
- We support and prioritize an annual appropriation to support operations and maintenance at the Cornell University Ruminant Center for dairy and cropping systems research, development and testing of new technologies for NYS dairy farmers to improve economic and environmental sustainability. Combined at the State Resolutions Committee Meeting with the resolution above. *Passed*
- We support and prioritize funding for Pro-Dairy, including the newly established climate leadership position, for applied research and development in dairy science as well as creation of a Dairy Innovation Hub for dairy and food science product development for larger and smaller scale dairy

- entrepreneurs. Passed
- We support the elimination of NDAs (Non-Disclosure Agreements) in solar leases to farmers. Combined with another resolution. *Passed*
- We do not support the state legislation that would prohibit certain wild animals from being transported to fairs for educational exhibition. *Passed*
- We support the amendment to NYS Ag & Markets law so that it would allow an on-farm meat processor to process meat from other farms as long as it would not exceed 49% of the total meat processed. *Passed*
- We support making the ST-125 Farmer's and Commercial Horse Boarding Operator's Exemption Certificate valid for 5 years instead of 1. *Passed*
- We support the state establishment of a state SNAP (Supplemental Nutrition Assistance Program) minimum benefit program. We also support funding and mechanisms to get food to rural food deserts.
   Failed – was felt that nothing should be taken away from the Federal Program.
- We do not support any legislation that would require wineries to collect and refill bottles. *Passed*
- We do support the suggested Bottle Bill increase from \$.05 to \$.10. *Passed*
- It is recognized that the cost for solar developers to install panels and batteries is very low due to tax breaks written into the Inflation Reduction Act. It is recognized that towns hosting installations can get from a PILOT agreement monies per megawatt, but also recognizing that the money is allocated by law. Towns can also receive money from a "Host Community Agreement" that is locally controlled as to allocation of funds. It is recognized that land under solar is no longer productive, or less productive for ag needs. If solar installations are to be sited on productive ag lands, we support a requirement that a portion of the income a host community generates through agreements be spent to support remaining farmland, making it more productive. Examples of investment include pattern tile drainage and precision farming technologies for smaller farm operators. **Died in Committee** – it was felt that there were other resolutions that addressed this.
- We do not support EPR for any ag related enterprise including wineries. If it passes we support a requirement that all agricultural related enterprises with less than \$5 million in gross receipts be exempted. *Died in Committee* – resolution for opposition passed.
- We support a cap on agricultural building appraisals that mirror the cap on agricultural land appraisals.
   Passed

They were not getting a proper assessment on a new 10 year exempt building as the county was not exempting the increase in value year to year. We got a ruling to his advantage.
